SCOPE-RD is part of the **Girls Advocacy Alliance (GAA)** Campaign working in collaboration with **Terre des Hommes–Netherlands** (TdH-NL) to promote secondary education and job oriented vocational training program for preventing child marriages and child trafficking of girl children and young women with an objective to provide equal rights and opportunities for them.

SCOPE-RD had taken up various activities related to advocacy & lobbying on child marriages this year in Khammam district, Telangana State as partner organization along with other NGO partners. SCOPE-RD plans to organise a workshop with district level Child Rights CSOs from GAA network to plan the district level advocacy action plan with a focus on secondary education for girls and JOVT for young women.

GAA, in Telangana intends to empower the girls not only through advocacy initiatives with Government and religious leaders but also it intend to motivate the Child Rights NGOs to include the GAA thematic interventions in their respective programs. Above all GAA intends to motivate these child rights NGOs to advocate with Government for bringing change in policy, Rule to prevent child marriage and support girls for acquiring secondary education and Job Oriented Vocational Education. Besides above GAA intends to strengthen the Child Rights NGOs collaboratively moving towards to see the pro child villages / panchayats at CSOs working areas in Khammam district.

GAA, in Telangana intends to empower the girls not only through advocacy initiatives with Government and religious leaders but also it intend to motivate the Child Rights NGOs to include the GAA thematic interventions in their respective programs. Above all GAA intends to motivate these child rights NGOs to advocate with Government for bringing change in policy, Rule to prevent child marriage and support girls for acquiring secondary education and Job Oriented Vocational Education. Besides that This consultation could help to improve the percentage of girl education so that the child marriages percentage can be reduced.

INNOVATIVE ACTIVITIES / PRACTICES



As part of our outreach activities we have **observed** that the **Photographers** plays important role in performing any marriage. We have interacted with the president photographers union khammam and advocated with him and discussed on child marriages and he agreed to pass a circular to the all the photographers union khammam while contracting with any marriage taking the required documents.

Situation happened: On 15-03-2019 GAA team invited for the **photographers work shop**. The photographer's union members nearly 2000 photographers participated. We found that the photographers plays key role in an marriage, they get the prior information about the marriage dates ,venue and other marriage related details

Advocacy asked for: We thought to convey the message about the Prevention of child marriages Act .We made advocacy with the photographer's president and requested him to pass a circular to the association members to verify the documents(Date of birth certificate, SSC memo &Aadhar card) before going to agreement with the marriage.

Inputs given on:

Child rights
Child marriage definition
About Prohibition of child marriages Act-2006
Penalties & Punishments who performs child marriages

Outcome: The Photographer association president & executive members agreed to give circular to the association members to verify the documents(Date of birth certificate, SSC memo & Aadhar card) before going to agreement with the marriage.

As part GAA team &GAA CSOs (CRADO, EFFORTS) network outreach activities they have observed that the Auto unions, porters in bus stand and railway stations and lorry unions plays important role in preventing the child trafficking. CRADO, EFFORTS CSO representatives have interacted with the president Auto union, Lorry union Khammam and advocated with him and discussed on the preventive methods of child trafficking issues. The trafficking mediums are more from Autos, Lorries, and through busses and trains. There are 15000 auto walas and 5000 lorry walas in Khammam . They are the best informers to the police and protecting mechanisms about child trafficking and other unions he agreed to conduct a orientation program to the 1500 auto walas and lorry walas on child trafficking and make them to involve in awaring the passengers and the public about trafficking and its consequences and the laws in it through activities, programs, pasting of posters and distribution of IEC material which could act as a vestal for trafficking cases.

Situation happened: On 29-05-2019 GAA team & CSOs network interacted with the Mr. Krishna president of Khammam Auto union and Mr. Srinivasa rao president of Lorry association Khammam, and explained the importance of roles of auto and lorry drivers in preventing the child trafficking.

Advocacy asked for: GAA CSOs network thought to convey the message about the types and consequences of child trafficking and the sections of ITPA-1956. We made advocacy with the Auto union president and requested him to pass a circular to the association members awaring the passengers and the public about trafficking and its consequences and the laws in it through activities, programs, pasting of posters and distribution of IEC material which could act as a vestal for trafficking cases.

Inputs given on:

1. Child rights 2. Child trafficking definition3. About the sections of ITPA

<u>Outcome</u>: The Auto association & Lorry association president & executive members agreed to give circular to the association members to conduct awareness camps and distribution of IEC materials and also awaring the passengers and the public about trafficking and its consequences and the laws in it through activities, programs, pasting of posters and distribution of IEC material which could act as a vestal for trafficking cases which could lead to the child safe areas in Khammam district.





Title: YAAH IN MALLS

Where did it happen: Different rushy shopping malls across

khammam distrtict

When did it happen: 16-11-2019

On 16th November 2019 YAAH Khammam team and GAA CSOs network has done program named "YAAH in Malls"

- 1. They went to various malls with dress code (GAA T-shirts and caps), explained to the management of the malls about the work and services of GAA.
- 2. They played "dhandiya" and "Bathukamma" in the malls and dragged the attention of the customers.
- 3. Explained to the staff and customers about the consequences of child marriage and child trafficking.
- 4. Youth advocates requested all of them to encourage secondary education or JOVT.
- 5. Explained about the supportive mechanisms available for rescue and rehabilitation for trafficked survivors and the supportive mechanisms available to protect the girl children.
- 6. Distributed IEC material to the customers and pasted in all the floors of various malls.

Nearly 800 people have gotten productive information about the girl child issues and supportive mechanisms.

These kind of activities done by the Youth advocates twice in a month.

Title: JIT (JUST IN TIME)

Where did it happen: KHAMMAM When did it happen: 16-11-2019

GAA CSOs network and GAA youth advocates have done an innovative programme they named it as JIT (JUST IN TIME)

"JIT" is like presenting about the child marriages and child trafficking message with in the span of 1 minute.

- 1) GAA CSOs network and our youth advocates had a new thought of interacting with the passengers in the bus about the girl child issues for only one minute.
- 2) They have taken permission from Bus Depot manager to get in to the buses in the bus stand, and interacted with the passengers for 1 minute.
- 3) They have explained about the consequences of child marriages and child trafficking.
- 4) And also the supportive mechanisms available for the rescue, safety and security of the girl child.

They have nearly awared 800 passengers and covered nearly 20 buses.

They decided to do this practice every Saturday once in a week at different bus stands of khammam district.









Title: GAA with train passengers

Where did it happen: Khammam, Bonakal, chinthakaani, madhira railway stations in khammam district

When did it happen: 19-11-2019

GAA CSOs network (Memunnamu, CRADO, SHIKA and Nenunnanu) has done awareness campaign in an innovative way named "GAA on wheels".

GAA CSOs network planned to conduct awareness campaign in trains and today they selected 3 trains "Dornakal Vijayawada passenger (24498) ", "Vijayawada to Badrachalam road passenger (24545) " and "Krishna Express (17406) " and they have done it.

- 1. They had an interaction with passengers and asked their opinion on these 2 thematic issues (CM and CT).
- 2. Some of the passengers responded positively and agreed that "we all have the responsibility to prevent child marriages and child trafficking".
- 3. Some of them did not agree and argued with CSOs.
- 4. GAA CSOs network explained them clearly and convincingly about the consequences of child marriage and child trafficking and supportive mechanisms available to protect the girl children.
- 5. Finally they explained to all the passengers about the consequences of child marriages, In what ways trafficking takes place and the supportive mechanisms through sound system in all the coaches of the train.
- 6. Distributed IEC material to the passengers and pasted in all the coaches of the trains.

Out put: With this innovative activity nearly 1500 people got awared about the girl child issues in 3 above said trains.

Title: Counters in Function halls

Where did it happen Sri ramachandra function hall, Khammam

& also Different function halls across district

When did it happen : 23-11-2019

GAA youth advocates and GAA CSOs network collaboratively taken permission from management of "Laxmi Chandra gardens" function hall where it is located at rural area of khammam.

- 1) They have arranged one "Display stall" which consists of the GAA IEC material.
- 2) They have given presentations to the public on the consequences of child marriages and child trafficking and also the importance of girl child education.
- 3) The supportive mechanisms available for protection and promotion of the girl child rights.
- 4) This stall attracted more women and men. It has created some curiosity among the public to know about the girl child issues especially child marriages.
- 5) Some of the people reacted positively and taken GAA poster with them to paste at their houses and at the floated community areas.

This stall has created some sort of stimulation among them to think twice while doing marriages and the importance of girl child education.





Title : GAA WITH TEACHERS UNIONS

Where did it happen: TPTF (TEALANGANA PROGRESSIVE TEACHERS FEDERATION), UTF (UNITED TEACHERS FEDERATION), PRTU of Khammam.

When did it happen : 04-12-2019

GAA team organised a consultation meeting with the Teachers unions like PRTU, UTF, TPTF.

Nearly 15000 teachers are officially registered and working under these unions only in khammam district.

We thought that they are the board network all over India & best means of transferring the message of GAA themes in to the targeted groups.

We made a dialogue with them on the GAA themes and it's working areas with different actors.

They are very happy to join their hands together for the safety and welfare of the girl child in khammam district.

They said that they will take this message to the bottom /root levels of the society through their hierarchy structures by utilizing the Youth Advocate clubs.

They have made a resolution to join their hands in GAA moment for the protection and promotion of the girl child rights.

From this moment Teacher unions are also the part of GAA as biggest network stake holders in khammam district.

On 06-11-2019 Mr. Niranjan & Mr.sadhiq pasha given representation to Mr. Thafseer Iqbal City police commissioner, Khammam to establish AHTUs Anti human trafficking Units in khammam district

SOME OF THE CASE STUDIES

Name of child: Sk. Raziya, Age: 16 Years, Gender: Female, DOB: 12-6-2002, Place of birth: Pedhakaakani village and mandal, Guntur district





Background information: Sk. Raziya D/o Venkateswara rao (step father) & saidabee residing at Pedhakaakani village. She failed in SSC i.e. 10th standard, staying at home. Her family back ground is very poor suffering from so many financial and psychological problems and she is in pathetic situation. Her parents are daily wage workers. Raziya is staying lonely at home from morning till evening. It has been observed by one person named Venkanna (lorry driver) friend of Raziya's brother in law, He diverted her through his chatting and trafficked her to Narasimhulapeta village Warangal. They stayed one day at Warangal and she relocated to another place **Guvvalagudem village**, **nelakondapalli mandal**, **khammam district**. They stayed there for 3 days she came to know that he was already married.

Intervention:

The neighbours suspected and informed to SCOPE-RD GAA on 18-02-2019. Then the team responded immediately, informed to the circle inspector Kusumanchi, CHILDLINE & also sub Inspector of police Nelakondapalli. The team reached the spot (home) along with police. She was alone at home without any ray of hope to reach her home safely. SCOPE-RD GAA team interacted with the child, she explained everything what was happened. The counsellor given counselling to the child and rescued her from that place. Counsellor and Raziya filed complaint against the accused named venkanna. Then our team and police traced the accused and remanded him in jail at Nelakondapalli police station. After that our team produced her before CWC (Child Welfare Committee) Khammam. Presently the survivor is placed at baalalasadhanam Khammam. The case is under process. All the line department officials responded quickly and cooperated well to SCOPE-RD GAA team to rescue the child. The child is very safe & happily staying at balala sadhanm Khammam at present. This case would be closed tentatively within 3 to 6 months. We are so pleasure and feel glad to rescue the child who is in need of care and protection.

Follow up: The child is rescued all the legal procedures are being done. The child is sent back to her home town Pedhakaakani village, Guntur district. Now the child is undergoing Tailoring training program

Name of child: Ch.Nandini, Father's name: Ravi (late) Mother's Name: Late: Vijaya, Age: 12 Years, Date of Birth: 22-11-2007 Gender: Female

Place of birth: Bokkal gadda, Near Ikalvoddu, Khammam Urban mandal, Khammam district.

Background information: Ch. Nandini D/o. Ravi resident of khammam. She is a school dropped out girl and she is a orphan girl staying at grandmothers house. She couldn't able continue her studies due to financial problems. Her situation was so pathetic. In order to continue her livelihood she started begging at roads of khammam.

Intervention: Mrs. Sridevi, Aruna representatives of (My people welfare organisation and secure) identified Nandini begging on the roads. Immediately they approached girl and rescued her from that situation and Informed to Mr. Sandeep GAA coordinator, khammam. He responded immediately and sent Mrs. Bharathi Youth advocate facilitator to that location. She went there and explained that girl about the situation brought her to GAA office. GAA CSOs and Youth advocate facilitator explained the importance of education and the consequences of begging. They have explained about the facilities given by the government to the orphan and semi orphan girls. The girl explained her situation to the GAA team members at last she got convinced to go to school through counselling, emotional guidance and support by the GAA CSOs and team members. After that GAA team taken the girl to her grandmother and explained her about the re-joining in to the school. After so many discussions and consents she got convinced to re-join her in to the school. Attent that Mrs. Bharathi GAA youth advocate facilitator taken the permission of special officer of KGBV rural School for the admission. She went to her along with Nandhini and explained her about the girls back ground and situation. At last special officer got convinced and given permission to rejoin that girl in 7th class. GAA CSOs given note books and hand holding amount to the girl to have good education to craft her career.

When: - On 07-07-2019 Mrs. Sridevi, Aruna representatives of (My people welfare organisation and secure) identified Nandini begging on the roads. Immediately they approached girl and rescued her fro that situation. Where:- From that place they have Informed to Mr. Sandeep GAA coordinator, khammam. He responded immediately and send Mrs. Bharathi Youth advocate facilitator to that location. She went their and explained that girl about the situation brought her to GAA office.

Current situation: GAA youth advocate facilitator is being in touch with the girl child regularly and giving continuous support and guidance to that girl to continue her studies.

What is the biggest change in the life of the beneficiary (preferably/if possible in his/her own words) as a result of this intervention?

The girl child says "When my parents paased away at my 10 years of age, I don't know about my future, I was completely drawn in depression. There was no way of hope for me to come out from the situation. I couldn't able to continue my studies, I was drawn in to situation of begging to support my self and my grandmother too.

Suddenly Mrs. Sridevi, Aruna representatives of (My people welfare organisation and secure) identified me begging on the roads. Immediately they approached me and rescued me from that situation. Then Mrs. Bharathi Youth advocate facilitator counselled me and given hope and confidence. I am so thank full to GAA team khammam and TdH –NL for taking such steps to save the girl child rights and making sure to join in school to continue my further studies and it could be helpful for me to lead my life happily.

Why is the PP/TdH-NL assistance important to the beneficiary (preferably/if possible in his/her own words)?

The girl says that In my view GAA (Girls Advocacy Alliance) is a great initiative who work for the girl child rights and empowerment. I must thank to GAA CSOs network, the team SCOPE-RD GAA &TdH-NL all the line department members because there should be someone to support the needy and to give counselling, guidance and moral support to helpless children like me to see some smiles and to show good future to them.



Name of the Organisation: SCOPE-RD GAA, Khammam Name of child: M. RAMYA Age: 14 Years Date of Birth: 10-04-2005

Gender: Female Place of birth: Mangala gudem village, Khammam Rural mandal, Khammam district.

Background information: M.Ramya D/o. Veeraswami residing at mangala gudem village studied till 6th class. She is a clever student and topper of the class. Her father is a daily wage worker, and her mother is house wife. Ramya sri is staying alone at home due to social and external force suddenly child's mother decided to get her married off to lessen the burden on the home. And the girl was forcefully obeyed the marriage proposal, the helplessness of the child became voiceless.

Intervention: The GAA Balika sangha/Youth advocate member informed about the ramya's marriage to the GAA Community mobilizer khammam. GAA team responded immediately and informed to CHILDLINE and CMPOs. The team reached the spot along with few people of the community. They tried to motivate the family to stop the marriage. Subsequently GAA team members counselled the girl, the team explained to her mother about the bad consequences of child marriages, Prohibition of Child Marriage Act and also child rights.

When: - Girl child marriage date fixed on 04-02-2019. The baalika sanghas /Youth advocate member informed to GAA community mobilizer/Youth advocate facilitator responded immediately went to the place along with concern departments and prevented the girl child from engagement. GAA mobilizer counselled her parents and girl child. Then her mother and family members agreed to stop the marriage proposal.

Where:-The marriage was stopped at mangala gudem village, Khammam district.

Finally Ramy sri's mother and groom's family members were convinced not to solemnize the marriage until she attains the age of 18. She was re-enrolled in Kishora balalaika vocational training program doing beautician course.

Current situation:

GAA community mobilizer is being in touch with the girl child regularly and giving continuous support and guidance to that girl to settle the girl.

What is the biggest change in the life of the beneficiary (preferably/if possible in his/her own words) as a result of this intervention?

The girl child says "When my marriage was fixed I was completely drawn in depression .There was no way of hope for me to come out from the situation. Suddenly the ray of hope came to me as GAA mobilizer. The way she counselled me and given hope and confidence". I am so thank full to GAA team khammam and TdH –NL for taking such steps to save the girl child rights and making sure to join in school to continue my further studies and it could be helpful for me to lead my life happily.

Why is the PP/TdH-NL assistance important to the beneficiary (preferably/if possible in his/her own words)?

The girl says that In my view GAA (Girls Advocacy Alliance) is a great initiative who work for the girl child rights and empowerment.
